Income Tax Information



All Americans are required to file Income Tax Returns each April. International students are often surprised to learn that they may have

tax filing obligations while they are in the United States. The Internal Revenue Service, or IRS, has specific tax filing requirements that can vary for each individual. All students working on campus should review the W-2 tax form sent to you by SRJC to determine your total income for the year. Due to the complexities of the U.S. tax system, we can only provide you with general information. Tax forms and instructions are available online at the websites listed below.

Time Change! What and Why?

Daylight Saving Time change is on March 8 this year. On that day, clocks are moved forward one hour in each time zone at 2:00 a.m. local time. Clocks are again shifted back in the fall.

The purpose of the shift is to transfer, in effect, an hour's worth of daylight from the early morning hours of the day, and use it to push back sunset until one hour later in the day. This arrangement is to cut electricity usage in the evening and help reduce traffic accidents.

Optional Practical Training Work Permission



Optional Practical Training (OPT) is a benefit of the F-1 Student Visa status that allows one year of full time employment to gain practical experience in your field of study. If you will be receiving your Associate degree this semester, you can apply for this benefit now. The employment must be directly related to your major. Processing time for Practical Training applications is about 3 months. You are not required to enroll in classes while on OPT. You can begin looking for a job a few weeks before you expect to receive your Employment Authorization card.

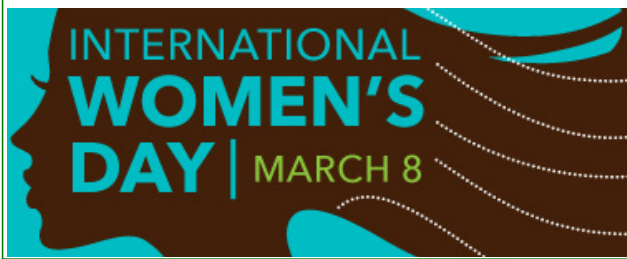
