## Maintaining Student Status

Below is an overview of the basic regulations for F-1 Visa students. Failing to maintain legal status could result in serious consequences and may affect the ability to remain in or return to the U.S. F-1 students must:

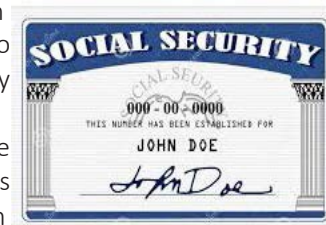
- Enroll in and successfully complete 12 units each fall and spring semester.
- Have a valid SEVIS I-20 from the school attending.
- Report any address changes to International Admissions within 10 days.
- Have legal permission for any employment.
- Limit enrollment in online classes to 3 units or one class per semester.

## Working During the Academic Term

F-1 students may work up to 20 hours per week on campus during the semester. To work on campus, the student will need to obtain a U.S. Social Security Number.

The Social Security Office requires international students to bring letters of permission from their school. Student Employment and International Admissions will provide the required letters.

Students who have completed one year as an F-1 student or have earned a degree in the U.S. may qualify for off-campus employment. Prior authorization is required. A workshop will be offered this fall to learn more about Curricular and Optional Practical Training possibilities.
